As conditions become more severe, as when temperatures move into the 240-300 °C (464-572 °F) range, trace quantities of 3, 3 dichlorobenzidine can be generated . 3, 3 dichlorobenzidine is classified as a suspect carcinogen by NTP and IARC , is classified as Acute Toxicity category 4 and Carcinogen Category 1 B according to 1272 2008 EC CLP, and is regulated by OSHA as a suspect carcinogen . In order to avoid the generation of and exposure to 3, 3 dichlorobenzidine , do

not use diarylide pigments in polymers when temperatures exceed 200 °C (392 °F).
